## REVISED STRATEGIES, PLANS CONDITION A28 SSD-9227, AMITY COLLEGE CAMPUS, LEPPINGTON

Outline Planning Consultants acts on behalf of Amity College.

In accordance with SSD- 9227 consent condition A28, the strategies, plans and programs required under this consent must be reviewed and the Planning Secretary and the Certifier must be notified in writing that a review is being carried out. The following advice is hereby submitted.

- Firstly, Amity College has revised the staging strategy for the project. In Mod 2, approved by the Minister's delegate on 14 July 2021, allowed the staging of the approved school project to be brought forward, along with minor design changes. This has meant that the overall capital works budget for the intended, revised Stage 1 works has now been brought forward and significantly increased, to an expenditure of in excess of \$15.5 million. The accelerated program for the school will generate much needed boost to the NSW economy at the same time as generating job opportunities for the NSW construction industry as well as professional teachers and support staff.
- The plans for the accelerated Mod 2 design are shown in the currently approved s.4.55 plans. Currently our firm is working on preparing a further modification application, to allow further minor design changes for Stage 1 of the project.
- Amity College issued tenders for early civil works in March 2021. These works have now been completed (October 2021). It is now proposed to commence in late November 2021 subject to the obtaining of a construction certificate and finalisation of the tender review process. It is expected that Stage 1 will be completed, ready for the opening of the Primary School, in the Term 1 of 2023.
- A Compliance Monitoring and Reporting Program will be prepared no later than 2 weeks prior to construction commencing on Stage 1.
- An *Environmental Management Plan* was prepared by contractors Lloyd Group in support of the early civil works, now completed. No incidents were recorded or complaints by neighbours. In regard to the latter, the contractors and the School gave effect to the *Community Communication Strategy Early Works and Stage 1*, prepared by Outline Planning Consultants. Refer to **Appendix A**. The School website has been updated to accord with this communication strategy. It is planned that this strategy will be further refined prior to Stage 1 works commencing, in the main to target a wider notification area in the local neighbourhood.

We trust that this information is sufficient for the purposes of SSD- 9227 consent condition A28.
