Wollar Solar Development proposes to construct, operate and decommission a photovoltaic (PV) solar farm with an estimated capacity of 290MW. The Wollar Solar Farm proposal would be located on a rural property approximately 7 km south of Wollar village. Mudgee is approximately 38 km south west from the proposal site and is the closest regional center for residents near Wollar to access services.

The land immediately surrounding the proposal site includes agricultural land predominantly grazed by cattle with limited cropping for feed, Crown Land, coal mining and a 500kV TransGrid substation. Coal mining is the main local industry for employment in the Mid-Western Regional Local Government Area (LGA), followed by beef cattle farming and primary education. There are three coal mines within the general vicinity north and north west of the proposal site.

We intend on formally lodging the Environmental Impact Statement to the Department of Environment and Planning in January 2019, and anticipate commencement of construction to be Q3/Q4 2019.

We understand numerous Crown Roads traverse the proposal site, and as such, with adjoining land owner support, have submitted a New Licence Application and Crown Road Purchase Application.

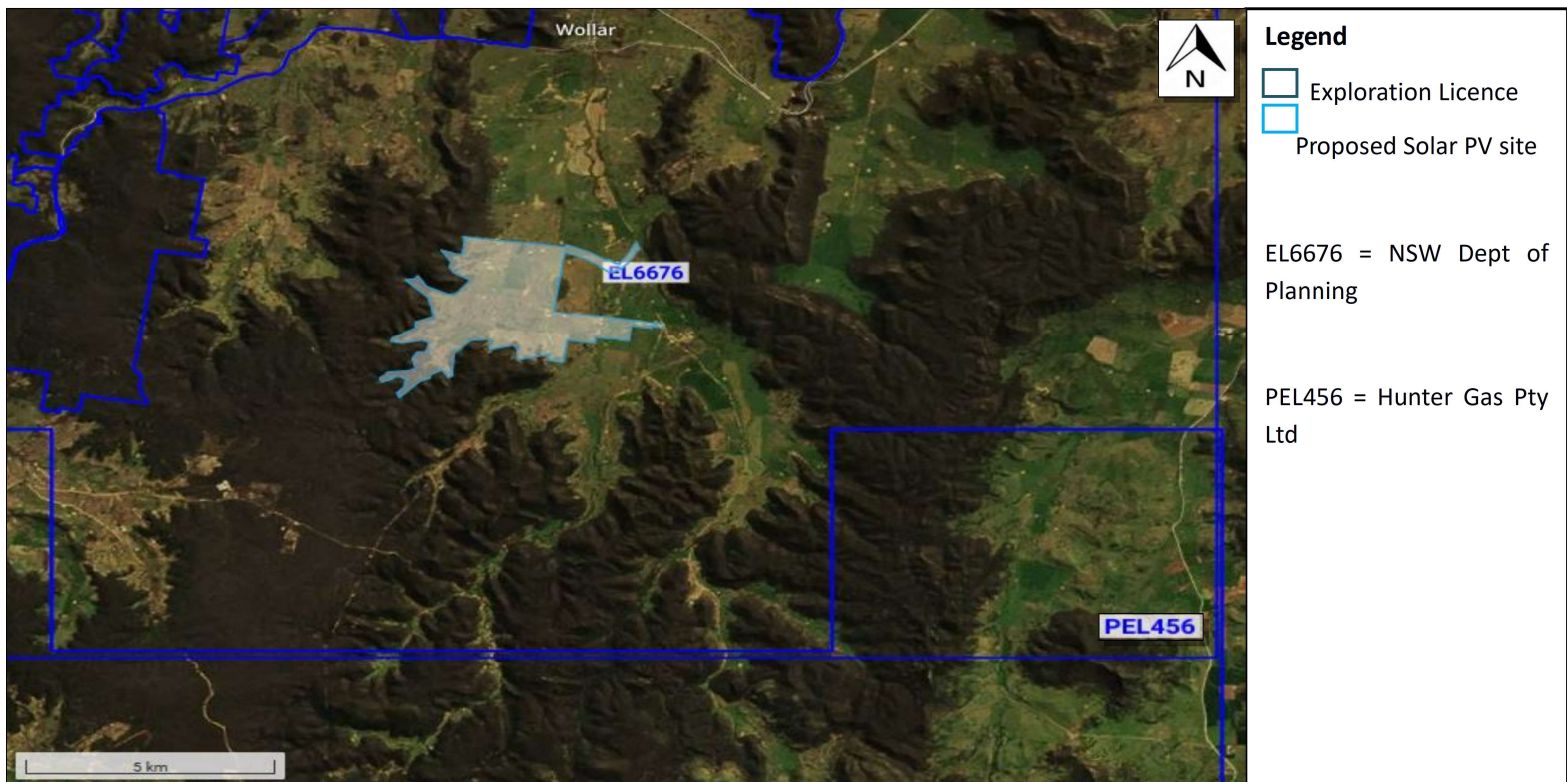
