Thanks for your time today.

As discussed, our conditions of consent (D8) requires that the street lighting (required by B22) is completed prior to school operations commencing as per the below conditions (full consent attached for reference);



As discussed, we are anticipating the delivery & installation of the street lights in late July.

Term 3 commences on Monday 20th of July.

The above timing represents a significant risk to the commencement of the operation of the school.
