**RE: Community Housing Provider for SSD – 93776214 at 849, 853, and 859 Pacific Highway and 2 and 8 Wilson Street, Chatswood**

I write in response to the Secretary's Environmental Assessment Requirements (SEARs) issued to BB Wilson Property Pty Ltd (Billbergia) for the Mixed-use in-fill affordable housing Development at 849, 853, and 859 Pacific Highway and 2 and 8 Wilson Street, Chatswood.

Billbergia have advised that the proposed development is designated as a State Significant Development (SSD) for assessment under the Housing Delivery Authority pathway.

Accordingly, Billbergia have advised that the proponent is required to provide confirmation of the registered Community Housing Provider who are proposed to manage the affordable housing component of the development for 15 years (after issue of Occupation Certificate).
