The mine development is permissible with consent. It is located within the Blayney and Cabonne Local Government Areas. All land within the mine development project area is zoned RU1 – Primary Production, and open cut mining is permissible within this zone under both LEPs. The pipeline corridor traverses the Lithgow, Bathurst and Blayney LGAs, and is permissible along the majority of the extent of the corridor. Permissibility is discussed in detail in Section 3.2.3 of the EIS.
