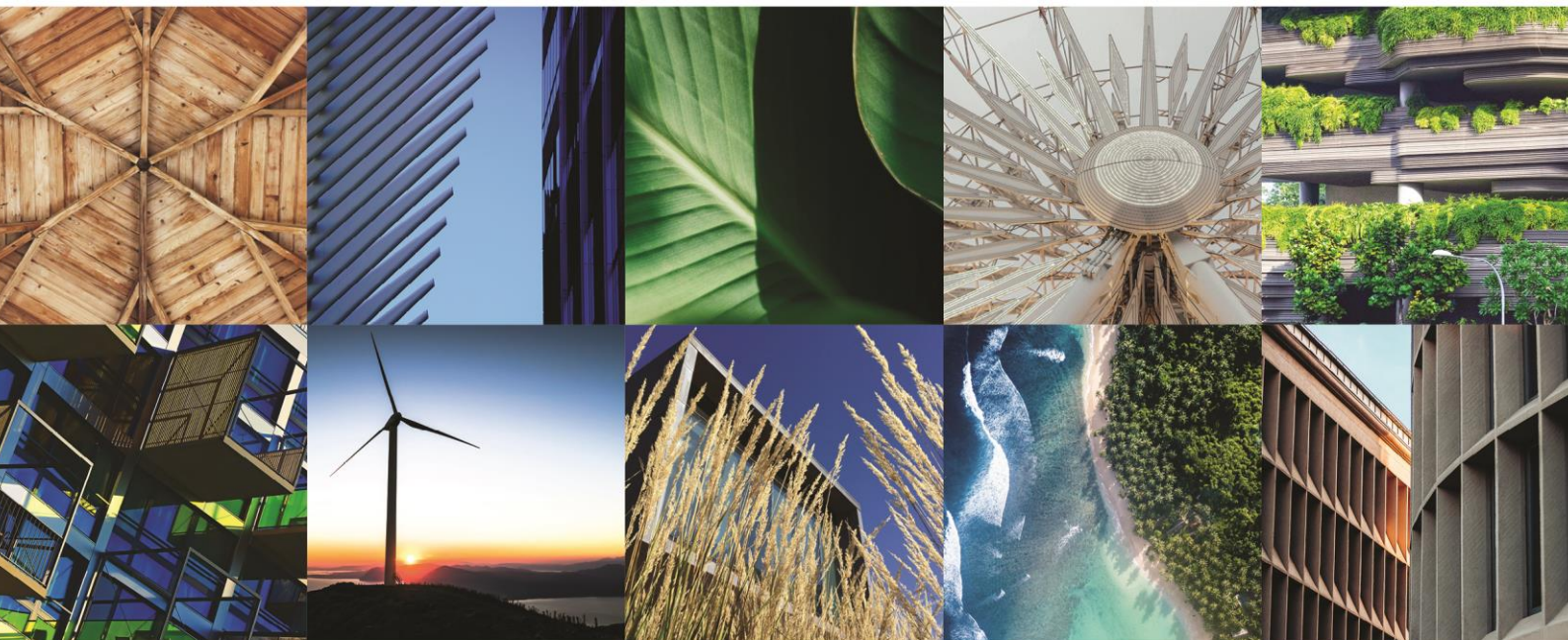

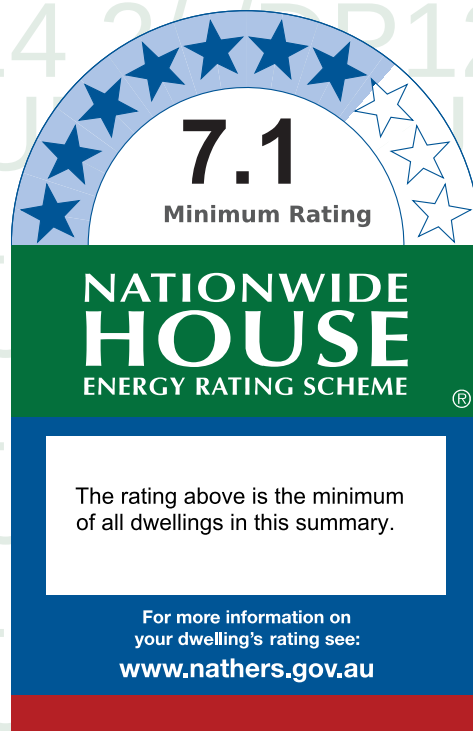

About the ratings
