STORMWATER QUALITY ASSESSMENT

Prior to a Construction Certificate being issued for any excavation, civil construction, drainage or building work (whichever is excluding approved preparatory or demolition work, a stormwater quality assessment must be undertaken and must be appeared a copy of the Council's letter of approval must be provided to the Principal Certifying Authority and Planning Secretary. The stormwater quality assessment must:

- (a) be prepared by a suitably qualified hydraulic engineer with experience in Water Sensitive Urban Design
- (b) use modelling from an industry-standard water quality model (e.g. MUSIC Model or equivalent)
- (c) demonstrate through reports, design plans and calculations, what water sensitive urban design and other drainage meas ensure that the development will achieve the following post-development pollutant loads:
- (i) reduce the baseline annual pollutant load for litter and vegetation larger than 5mm by 90%;
- (ii) reduce the baseline annual pollutant load for total suspended solids by 85%;
- (ii) reduce the baseline annual pollutant load for total phosphorous by 65%;
- (iv) reduce the baseline annual pollutant load for total nitrogen by 45%.

(d) include certification from a suitably qualified practicing professional that the requirements of parts (i) (ii) (iii) and (iv) of t been met.
