## **Description of proposal**

Development of a new 235 megawatt underground pumped hydro-electric power station, tunnels, underground and overground water pipelines, surge tanks, intake and outlet structures and ancillary infrastructure, between Fitzroy Falls Reservoir and Lake Yarrunga.

#### About the re-exhibition

An exhibition process allows any individual or organisation to have their say about a proposed development.

The Department of Planning and Environment (Department) received a Critical State significant infrastructure (CSSI) application for the abovementioned proposal, which was publicly exhibited in November 2022.

Due to a procedural error by the Proponent, the application is being re-exhibited.

The application, environmental impact statement, and accompanying documents are unchanged from the original exhibition and are on re-exhibition from **Friday 13 January 2023** until **Friday 10 February 2023**. You can view these documents online at <u>planningportal.nsw.gov.au/major-projects</u>.

All submissions made during the original exhibition period will be considered during the assessment and **do not** need to be re-submitted.

At the time of publishing this advertisement, the Minister for Planning has not directed that a public hearing should be held.

Controlled Action under Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act)

Development in NSW can be subject to Commonwealth legislation, depending on the circumstances.

The Commonwealth Minister for the Environment and Water has decided that the proposed development – known as Shoalhaven Hydro Expansion (2022/09293) for Commonwealth purposes – is a "controlled action" under the EPBC Act.

The EPBC Act Part 3, Division 1 controlled provisions are Sections 18 and 18A (Listed threatened species and communities).

The proposed development 2022/09293 will be assessed under Part 5 of the *Environmental Planning and Assessment Act 1979*. The assessment will be in accordance with the Bilateral Agreement between NSW and the Commonwealth, made under the EPBC Act. The assessment will be done in the manner specified in Schedule 1 of the Bilateral Agreement. This means the project will be assessed against the requirements of both acts.
