I refer to the Stage 2 Compliance Statements submitted to the Department under condition D38 of SSI-10040 and in accordance with the Department’s letter to Transgrid dated 20/05/2022.

I note the Stage 2 Compliance Statements:

- include mitigation measures consistent with those identified in the Stage 2 Traffic Strategy;
- include the relevant implementation details for each mitigation measure;
- have been reviewed by Transgrid and no issues were raised; and
- contain the information required by condition D38 as detailed in the Department’s letter dated 20/05/2022.

In addition, and in accordance with the Department’s 20/05/2022 letter, the Department has undertaken a separate assessment of the Compliance Statements listed in Table 2 below, for Access Point 82A and Fletchers Lake Road, as these are located within 500 metres of a sensitive receiver.

The Department notes that these Compliance Statements confirm the implementation of relevant mitigation measures applying prior to or during the installation of the Access Points, and confirm that the Access Points would continue to be used in accordance with the mitigation measures relating to their use. These measures included completion of additional survey assessment at Fletchers Lake Road and limiting of works to standard construction hours at both sites.

Based on this review, the Department is satisfied that the Compliance Statements listed in Table 2 below satisfy the Planning Secretary of the mitigation measures required by Condition D38 for the corresponding Access Points listed in Table 2, and no further assessment is required.
