Dear Ms Hargreaves

I refer to your submission dated 21 September 2022 of the Risk Assessment under condition A19. I also acknowledge your response to the Department's review comments and request for additional information, including the revised Risk Assessment, titled *Environmental Risk Assessment: Moorebank Avenue Realignment Works* (31 October 2022).

## Combining of Plans, Procedures or Strategies

I note your proposal to combine 20 documents required by the SSI Approval and EIS, into the Community Communications Strategy, CEMP and nine CEMP Sub-Plans.

The Department has reviewed this proposal and is satisfied that the proposed consolidation will not preclude the Project from meeting its obligations under the SSI Approval.

Accordingly, as nominee of the Planning Secretary, and under condition A6, I agree to:

- The inclusion of the Construction Noise and Vibration Monitoring Program into the Construction Noise and Vibration Management Plan.
- The inclusion of the Unexpected Finds Procedure for Contamination into the Contamination Management Plan.
- The consolidation of the Aboriginal Heritage Management Plan, Historic Heritage Management Plan, and Unexpected Finds Procedure for Heritage, into a Construction Heritage Management Plan.
- The consolidation of the Water Management Plan, Erosion and Sediment Control Plan, Soil and Water Management Plan, Flood Emergency Response Plan and Surface Water Monitoring Program into a Construction Soil and Water Management Plan.
- The inclusion of the Spoil Management Plan into the Construction Waste and Resource Management Plan.

Nomination of Documents to be endorsed by the ER instead of being submitted to the Planning Secretary for approval

I note the Risk Assessment proposes the Planning Secretary's nomination of documents to require ER endorsement only.

The Department has reviewed the Risk Assessment and proposed documents, and considers the proposed documents are for environmental aspects which are 'low' or 'medium' risk.

Accordingly, as nominee of the Planning Secretary, and under conditions C8 and C9, I nominate the following documents to be endorsed by the ER:

- Construction Traffic and Access Management Plan.
- Contamination Management Plan.
- Construction Heritage Management Plan.
- Construction Soil and Water Management Plan.
- Construction Air Quality Management Plan.
- Bushfire Management Plan.
- Construction Waste and Resource Management Plan.

I note that the following documents must be submitted to the Planning Secretary for approval:

- Construction Environmental Management Plan (CEMP), under Condition C2.
- Construction Noise and Vibration Management Plan (CNVMP), under Conditions C8 and C14.
- Community Communications Strategy (CCS), under Condition B6.

## Nomination of NSW Government Agencies and Stakeholders

I also note the Risk Assessment has nominated, and provided to the Planning Secretary for information, a list of NSW Government Agencies and Stakeholders for consultation during preparation of the CCS, CEMP and CEMP Sub Plans.
