Description of proposal

Hunter Transmission Project, which includes:

- development of a new double circuit 500 kilovolt (kV) transmission line between new switching stations at Bayswater South and Olney;
- development of new 500 kV Bayswater South and Olney switching stations;
- adjustments and/or upgrades to existing 500 kV transmission lines at Ravensdale and Bayswater to connect to the proposed switching stations, and to existing 330 kV transmission lines;
- modifications to the existing Bayswater and Eraring 500 kV / 330 kV substations; and
- ancillary infrastructure such as site offices, temporary workforce accommodation camps, internal roads and grid connection to the transmission network.

About the exhibition

An exhibition process allows any individual or organisation to have their say about a proposed development.

The Department of Planning, Housing and Infrastructure (Department) has received a critical State significant infrastructure application for the abovementioned proposal. The application, environmental impact statement, and accompanying documents are on exhibition from Wednesday 27 August 2025 until Wednesday 24 September 2025. At the time of publishing this advertisement, the Minister for Planning and Public Spaces has not directed that a public hearing should be held.

Controlled Action under Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act)

Development in NSW can be subject to Commonwealth legislation, depending on the circumstances.

The Commonwealth Minister for the Environment and Water has decided that the proposed development – known as Hunter Transmission Project (2024/09874) for Commonwealth purposes – is a "controlled action" under the EPBC Act.

The EPBC Act Part 3, Division 1 controlled provisions are:

- Sections 18 and 18A (listed threatened species and communities); and
- Sections 26 and 27A (Commonwealth land).

The proposed development (2024/09874) will be assessed under Part 5 of the *Environmental Planning and Assessment Act 1979*. The assessment will be in accordance with the Bilateral Agreement between NSW and the Commonwealth, made under the EPBC Act. The assessment will be done in the manner specified in Schedule 1 of the Bilateral Agreement. This means the project will be assessed against the requirements of both acts.
