### **CSSI 7475 INLAND RAIL – PARKES TO NARROMINE – INSTALLATION OF AT-PROPERTY TREATMENTS FINALISED**

ARTC is pleased to provide an update to the Department of Planning, Industry and Environment (the Department, DPIE) regarding the installation of operational at-property treatments pursuant to Condition E12 of the Inland Rail - Parkes to Narromine Conditions of Approval (SSI 7475) (CoA).

ARTC would like to inform the Department that operational at-property architectural treatments were installed at Lot 18 DP755113 by 30 June 2020, as approved by a nominee of the Planning Secretary in correspondence dated 16 June 2020 (refer Attachment 1). Installation of the operational at-property treatments at Lot 18 DP755113 marks the final at-property architectural treatment required by the Operational Noise and Vibration Report (ONVR) (CoA E11). Consequently, ARTC believes that the requirements of CoA E12 have been fulfilled.


I note that this is the fourth extension requested by ARTC. Previous extension requests include:

- On 20 August 2019 ARTC requested an extension to 31 January 2020 due to changes in scope in response to resident feedback and requests.
- On 22 November 2019 this request was further amended to 30 March 2020 to accommodate further resident requests and the Christmas and New Year period. This request was approved by the Department on 6 December 2019.
- On 6 February 2020, ARTC requested an extension of time to 24 April 2020 for Lot 134 DP755113 as the landholder requested works be carried out during the April school holidays. This request was approved by the Department on 11 February 2020.

As nominee of the Planning Secretary, I approve the extension of time to 30 June 2020 for implementing operational noise mitigation measures at Lot 18 DP755113 as requested in your letter dated 19 May 2020, pursuant to condition E12. I encourage you to complete the works by this date.
