### **SEARs for M4-M5 Link (SSI 7485)**

The Department has prepared these SEARs to reflect the amendments to the application provided to the Department on 22 September 2016 which includes the proposed construction of a tunnel from the southern abutment of the Iron Cove Bridge at Rozelle to the proposed Rozelle Interchange.

If you do not lodge an EIS for the proposal within two (2) years, you must consult further with the Secretary in relation to the preparation of the EIS.
