1. Introduction

1.1. Context

This UDLP Submission Extension Report details the Project's intent for an extension of time to the approval date of the UDLP to the Secretary for Department of Planning, Industry and Environment. The report also identifies works potentially subject to the UDLP scheduled to commence prior to approval of the UDLP.

This report has been prepared to satisfy the Minister's Condition of Approval (CoA) A8 and E136.

1.2. Scope and Purpose of this Report

The Project is seeking an extension of time for the approval of the UDLP, with a proposed deadline of the 31st of March 2021. In accordance with CoA A8, this document will fulfil the requirement for a written request to the Secretary to propose an alternate approval date. Additionally, the Project seeks confirmation that the works outlined in Section 2 of this Report are able to commence prior to the approval of the UDLP, in order to satisfy CoA E136.

2. Works commencing prior to extended deadline

A number of elements of the project that are subject to the Urban Design and Landscape Plan (UDLP) are due to commence before 31st March 2021. A summary of these works is included in Table 1 below.
