

COFFS HARBOUR BYPASS (CSSI-7666) ENVIRONMENTAL REPRESENTATIVE MONTHLY REPORT October 2021

Reporting Period: 1 to 31 October 2021

This Environmental Representative Monthly Report is prepared in accordance with the Minister's Condition of Approval A25(j) for the Coffs Harbour Bypass (CSSI-7666) and is consistent with the Environmental Representative Protocol (August 2018).

PROJECT SUMMARY: The construction and operation of a new multi lane road from north of Sawtell Road Interchange to Sapphire, and including:

- A new four-lane divided highway with three grade-separated interchanges at Englands Road (southern),
 Coramba Road (central) and Korora Hill (northern);
- Three tunnels through ridges, at Roberts Hill (approximately 190m long), Shephards Lane (approximately 360m long and Gately Road (approximately 450m long);
- Structures to pass over local roads and creeks, and a bridge over the North Coast Railway;
- Tie-in and modifications to the existing road network, to enable local road connections;
- Pedestrian and cycling facilities, a shared path tying into the existing share path on Solitary Islands Way, and a new pedestrian bridge to replace the existing Luke Bowen footbridge;
- A new Korora Public School bus interchange and a formalised bus stop at Coramba Road; and
- Noise attenuation measures, fauna connectivity structures, and ancillary work.

 - Environmental and Engineering investigations
- Main Construction Works RFT

Community Consultation and Complaints

Collateral

- Coffs Harbour bypass news bulletin format was distributed 31th October. The key story featured shortlisted
 applicants invited to formally tender and probable new species. Some negative comments were received about
 how long the project is taking before major construction starts.
- Three Facebook posts on early work progress was distributed during October reaching on average between 45,000 50,000 community members per post.
- The Shortlisted Applicants Media Release was distributed on 12th October
- The website was updated to include the Shortlisted Applicants story and the Aboriginal Participation Strategy

Meetings

The Coffs Harbour Bypass Action Group. CHB Senior Development Manager, Environment Manager and AA met with the Chair and Vice Chair and a third representative of CBAG. The meeting was mostly on the latest noise validation reports. Other issues were minimally discussed to include the road shoulder in the tunnels for cyclists, probable new species and impacts to koala habitats.

Directly Impacted Stakeholders

- A notification about clearing work on Coachmans Close was distributed to approximately 60 households.
- Other notifications were distributed for other early work which had very little stakeholder impacts (2-3).



Community Display Office

- Community Display Office relocated to 54 Moonee Street reopened on the 6th October with new opening hours
 of Wednesdays from 10am 4pm. Two people attended inquiring about employment on the CHB.
- 32 emails were received and 15 phone calls

Key Themes

- Generally, feedback has been positive with the majority of inquiries regarding when work will get started, particularly major construction. Other key topics include:
 - Eligibility for At-house noise treatment or when they were receiving AHNT;
 - Project timelines pertaining to major construction;
 - Employment opportunities; and
- Engagement of local businesses
