These conditions call for the Proponent to:

C8	Construction must not commence until the <b>CEMP</b> and any <b>CEMP Sub-plan</b> specified in <b>Condition C3</b> have been submitted to, or approved by the Secretary. The <b>CEMP</b> and <b>CEMP Sub-plans</b> submitted to, or approved by the Secretary, including any minor amendments approved by the ER must be implemented for the duration of construction. Where construction of the CSSI is staged, construction of a stage must not commence until the <b>CEMP</b> and <b>Sub-plans</b> for that stage have been submitted to, or approved by the Secretary.

Transport for NSW have reviewed the attached Traffic and Transport and Access Management Sub-plan and believe it is of a suitable quality and addresses the Conditions of Approval and documents referenced in Condition A1 as required. Consultation as described in Condition A5 is included as an appendix to Plan.

The Environmental Representative has endorsed the relevant document for submission to the Secretary. The endorsement is included in the transmittal.
