**Parramatta Light Rail Stage 1 (SSI 8285)  
Package 5 Supply Operate and Maintain  
Construction Environmental Management Plan (CEMP) and sub plans**

I refer to your submissions requesting approval of the Construction Environmental Management Plan (CEMP), Construction Heritage Management Sub Plan (CHMP) and Construction Noise and Vibration Management Sub Plan (CNVMP) for the Parramatta Light Rail Stage 1, in accordance with Condition C8 of SSI 8285.

I also acknowledge that these documents have been submitted in accordance with the staging report for the Parramatta Light Rail Stage 1 project.

I note that the CEMP has been prepared to address the Activity A component of works at the Stabling and Maintenance Facility only, however the CHMP and CNVMP address the entire scope of the Package 5 works (Activities A and B).

I also note that the CEMP, CHMP and CNVMP:

- have been reviewed by Transport for NSW and no issues have been raised;
- have been prepared in consultation with relevant Councils, and agencies where required;
- have been endorsed by the Environmental Representative (ER); and
- contain the information required by the conditions of approval.

As nominee of the Planning Secretary, I approve the following documents listed in the table below, pursuant to conditions C1 – 8:

You are reminded that Activity B works must not commence until an updated CEMP that includes the complete Package 5 scope of works has been approved by the Planning Secretary. The updated CEMP must be endorsed by the ER and then submitted to the Planning Secretary for approval no later than one month before the commencement of construction.

You are also reminded that if there is any inconsistency between the approved CEMP, CHMP and CNVMP and the conditions of approval, then the requirements of the conditions of approval will prevail.
