Noise and vibration complaints

- Various noise complaints received by Communication teams reviewed daily by AA, some specifically investigated below from 26 November (greater detail in Inspections / Actions section below):
 - Complaint #709 30 Hainsworth Street (Wesley Apartments)
 - 5 families complained within the last week of November. Noted that due diligence has been completed by Parramatta Connect to-date, and consideration of residents is on-going.
 - Complaint #708 Lennox Bridge
 - complaints pertaining to public concern over structural damage. Investigation has identified that cracks are unrelated to PLR works.

Inspections / Actions

- November Inspections all completed by RT (Alternate AA inspections)
- Fortnightly Inspection (#15) 4th November 2020, no actions required:
 - Observation of vibration monitor installation and completion of monitoring at neighbouring sensitive site, during CFA piling activities.
- Fortnightly Inspection (#16) 13th November 2020, no actions required:
 - Area 2 Macquarie St (Excavation/Vac Trucks OOHW HNIW)
 - Area 3 Crane lifting beams to Tramway Avenue Bridgework
- Fortnightly Inspection (#17) 24th November 2020:
 - Area 3 General review of state of site, plant in use, and noise mitigation measures
- Fortnightly Inspection (#18) 24th November 2020:
 - ° OOHW noise monitoring at ATC grounds keeper's house during CFA Piling at SaM site
- Review of ER inspection documentation.
- Review of TfNSW inspection documentation.

Non-compliance and incident details

- Nil related to AA activities/inspections
- Nil forwarded to AA for consideration

Ongoing and upcoming environmental risks (noise and vibration)

- Ongoing concerns with construction through Cumberland precinct:
 - OOHW construction adjacent 30 Hainsworth Street (Wesley Apartments).
 - ° Cumberland Hospital Bunya Facilities high ground-borne noise predicted.
 - $^{\circ}$ $\,$ flying fox colony rearing season.
 - Identification of 600mm asphalt below sections of Eat Street (early December), additional HNIW activities than previous estimated will occur to remove.
 - ° Routine complaints from apartment buildings at intersection of Church St, and Victoria Road.
- AA will focus inspections and management review of above items during December.

Recommendations / Advice (incl auditing)

• AA recommended that P5 SOM: CNVMP (Rev F) consultation include Cumberland Council despite no predicted impact to heritage items (as per C5,9,10,12).





- Pending response from the EPA, and response to AA concerns, requesting the consideration of alternate criteria (departures from RING/CoA) in consideration of Greenfield and Brownfield criteria application, due to existing noise levels potentially exceeding the target criteria.
 - ° At present identified that INF and SOM teams are progressing targeting meeting RING/CoA.

Outstanding Queries

- Internal inspections of Cumberland facility buildings, including review of ground-borne noise concerns.
- Workshop to consolidate INF and SOM ONVR packages did not close out all items. AA to prepare a revised list of expectations for deliverable items from each team, for review by TfNSW.

Other Items

• With COVID-19 border ccrossing relaxing between QLD and NSW, primary AA (Beau Weyers), targeting to attend site in December 2020 or early January 2021.
