# Powering Sydney's Future (SSI 8583) Variation to Approved Construction Hours – Sydenham Road and Old Canterbury Road trenching and conduit installation

I refer to your request (SSI-8583-PA-45) submitted on 20 January 2021 for the Planning Secretary's approval of high risk out of hours works for the Powering Sydney's Future project (SSI 8583).

The Department notes that your previous request in relation to this package of high risk out of hours works for the Powering Sydney's Future project (SSI 8583-PA-41) was approved by the Planning Secretary on 14 January 2021.

The Planning Secretary's previous letter of approval, dated 14 January 2021, is subsequently superseded by this updated approval letter.

The Department has reviewed your revised requests to extend construction hours to carry out trenching, conduit installation and road restoration on Old Canterbury Road and sections of Hanks Street and Arlington Street, Hurlstone Park.

I note there are no revisions to the package of works for Sydenham, Road, Marrickville.

The Department accepts the requests to vary constructions hours subject to the following:

#### Sydenham Road, Marrickville package of works:

- 1. The works must be undertaken as detailed in the *Out of Hours Works Permit* (008 Rev 1) prepared by Taihan (SSI-8583-PA-41) and in accordance with the *Out of Hours Works Construction Noise and Vibration Impact Statement* (prepared by VMS Australia dated 3 September 2020), unless otherwise varied by the conditions below.
- 2. Work must not be undertaken outside the hours of work identified in Condition E4 of SSI 8583 (Approval), except for the works and hours detailed below:

a) up to 34 shifts of night work on Sydenham Road, Marrickville around the intersection with Centennial Street, in the area delineated in Figure 1 of the *Out of Hours Works Permit* (008 Rev 1), between 20.00 on 22 January 2021 and 05.00 on 30 April 2021.

## Old Canterbury Road and sections of Hanks Street and Arlington Street, Hurlstone Park package of works

- 1. The works must be undertaken as detailed in the *Out of Hours Works Permit* (009 Rev 03) prepared by Taihan (SSI-8583-PA-45) and in accordance with the *Out of Hours Works Construction Noise and Vibration Impact Statement* (prepared by VMS Australia dated 3 September 2020), unless otherwise varied by the conditions below.
- 2. Work must not be undertaken outside the hours of work identified in Condition E4 of the Approval, except for the works and hours detailed below:
  - a) Conduit installation: up to 14 days, including ten-night shifts (18:00–07:00 the following day) and two Saturday afternoon shifts (13:00–18:00), from 27 January 2021, on Old Canterbury Road and sections of Hanks Street and Arlington Street, Hurlstone Park, in the area delineated in Figure 1 of the *Out of Hours Works Permit* (009 Rev 03). Work will be carried out during day and night shifts, as per TMC approval. There will be a maximum of six consecutive day shifts and five night shifts per week.
  - b) Road restoration will be completed following TMC road occupancy approval. Work will take place over seven days, including five night shifts (18:00-07:00 following day) and one Saturday afternoon shift (13:00-18:00). Shift pattern will reflect the below. The end date of OOHW is 27 April 2021.

### Applicable to both packages of out of hours works being Sydenham Road, Marrickville and Old Canterbury Road and sections of Hanks Street and Arlington Street, Hurlstone Park:

- 3. Written notice must be provided to surrounding residential occupiers and placed on site at least 48 hours before work occurs outside the normal construction hours identified in Condition E4. The written notice must:
- I. identify what works are to occur outside normal construction hours;
- II. nominate the timeframe the works are likely to occur:
- III. be reissued 24 hours before any work occurs outside normal construction hours if the wet weather requires an alternative day from that notified; and
- IV. provide a telephone contact number dedicated to the project during that will be operational throughout the extended construction hours.
- 4. A record of any complaints made regarding works undertaken during the extended construction hours must be provided to the Department's Compliance team within 24 hours of the complaint.
- 5. In the event that any complaint is received, appropriate mitigation measures are to be implemented, and the Department and the complainant are to be informed of the actions undertaken to address the complaint.
- 6. All noise management controls as described in Section 9 of the *Out of Hours Works Noise and Vibration Impact Statement* (prepared by VMS Australia dated 3 September 2020), are to be adopted and implemented for the duration of the works.
