**Stage 1A - Western Harbour Tunnel and Warringah Freeway Upgrade (SSI 8863)
Construction Environmental Management Plan and Sub Plans – Condition C3 and C9**

I refer to your submission on the Construction Environmental Management Plan (CEMP) and associated sub-plans and procedures (CEMP package) to manage the site establishment and construction works.

I note that you are staging the project under condition of approval A10 and have submitted the CEMP package to manage the impacts associated with Stage 1A 'Early and Enabling works' as detailed in the Staging Report, Revision 0, dated 1 March 2021 (Staging Report).

You have submitted the CEMP package to address the requirements under conditions of approval detailed in the attached table and in accordance with the Staging Report.

I acknowledge that the Staging Report has classified some activities associated with Stage 1A as low risk and consultation has been undertaken with North Sydney Council and relevant government agencies as detailed in the Staging Report.

I also note:

- this CEMP package only relates to Stage 1A as outlined in the Staging Report, Revision 0, dated 1 March 2021;
- the CEMP package has been reviewed by Transport for NSW and no issues have been raised;
- the CEMP package was reviewed and endorsed by the Environmental Representative (ER), Mr. Maurice Pignatelli;
- the Noise and Vibration Management Sub Plan (Revision 4) and Monitoring Program (Revision 3) have been prepared in consultation with NSW Health, North Sydney Council and the EPA, and reviewed by the Acoustic Advisor Mr Larry Clark;
- the Transport and Traffic Management Sub Plan (Revision 2) has been prepared in consultation with North Sydney Council;
- the CEMP, Sub Plans and Procedures have been reviewed by the environmental consultant Cardno and feedback was incorporated into the revised documents; and
- contains the information required by the conditions of approval and the revised environmental management measures.

Accordingly, as a nominee of the Planning Secretary I approve the CEMP, Sub Plans and component procedures in accordance with the Staging Report and the conditions detailed in **Attachment A** below.

Please ensure that the approved documents are placed on the project website before the relevant works commence as per condition B15.

Further, you must ensure that you seek all relevant approvals prior to the commencement of future stages as detailed in the Staging Report and in accordance with the timing requirements of the conditions of approval.

You are reminded that if there is any inconsistency between the approved CEMP and the conditions of approval then the requirements of the conditions of approval will prevail.
