Construction Environmental Management Plan, Sub Plans and Monitoring Programs –
Conditions C3, C10 and C20

I refer to your submissions requesting the Planning Secretary's approval of the Construction Environmental Management Plan (CEMP) Revision 2, dated 26 October 2021, Sub Plans and associated Monitoring Programs listed in the table below for the M6 Stage 1 Project, Stage 1 – Preliminary Construction, in accordance with conditions C3, C10 and C20 of SSI 8931. The Department has completed its review and I thank you for your response to requests for further information.

I note that the CEMP, Sub Plans Monitoring Programs listed above:

- have been reviewed by Transport for NSW (TfNSW) and no issues have been raised;
- are consistent with the project Staging Report, Rev 0, dated 06 September 202;
- have been reviewed by environmental consultant Cardno Pty Ltd;
- have been prepared in consultation with relevant Councils, and agencies where required;
- have been endorsed by the Environmental Representative (ER); and
- contain the information required by the conditions of approval.

I also note that the CCMP was reviewed and endorsed by the Environmental Protection Authority's accredited Site Auditor Mr Brad May of EPIC Environmental Pty Ltd and the Auditor has issued an Interim Audit Advice confirming the appropriateness of this plan.

Further, the CNVMP and CNV Monitoring Program were prepared by noise specialist Renzo Tonin and Associates and reviewed and endorsed by the Project's Acoustic Advisor.

As nominee of the Planning Secretary, I approve the CEMP (Revision 2, dated 26 October 2021), and the Sub Plans and Monitoring Programs listed in the above table pursuant to conditions C3, C10 and C20, subject to the following condition:

- section 4.3 of the CEMP (Revision 2) and the table of contents is required to be updated to remove the reference to Appendix B6. Section 4.3 is required to include a link to the Heritage Management Plan.

I note that you have made attempts to consult with NSW Health, however, due to the ongoing COVID 19 pandemic, NSW Health resources have been unable to provide comment on the relevant management plans. I remind you that any future comments from NSW Health will be required to be incorporated in the CNVMP and CAQOMP.

You are also reminded that if there is any inconsistency between the approved CEMP, Sub Plans and Monitoring Programs listed above and the conditions of approval then the requirements of the conditions of approval will prevail.
