Sydney Gateway (SSI 9737) Provision of future infrastructure (Condition E37)

I refer to SSI 9737 (Sydney Gateway) which was approved by the Minister for Planning and Public Spaces on 27th August 2020.

Condition E37 states:

The CSSI must not preclude both a future rail turn-out facility at Cooks River Intermodal Terminal and ramps between the CSSI and Canal Road. A statement, including relevant details and diagrams, must be provided to the Planning Secretary prior to construction commencing in the vicinity demonstrating that this infrastructure has not been precluded.

John Holland Seymour Whyte Joint Venture (JHSWJV) advises that the Sydney Gateway Road Project (approved under CSSI 9737) does not preclude both a future rail turn-out facility at Cooks River Intermodal Terminal and ramps between the CSSI and Canal Road. Relevant details include:

- Ramps: Space proofing has been undertaken to demonstrate feasibility of the future exit and entry ramps. Please refer to Attachment 1.
- Rail: Vertical clearance to the future rail has been achieved by conducting vertical clearance checks. Please refer to Attachment 2.

The enclosed drawings (noted below) demonstrate the future rail turn-out facility at Cooks River Intermodal Terminal and ramps between the CSSI and Canal Road are not prohibited:

- Ramps: Attachment 1 –
 - Plan view of future ramp - SG-20-AAJ-1000-RD-IFD-20210202-FUTURE-DESIGN-1001 to 1003
 - Minimum vertical clearance of SB02 over Canal Road - SGWS1-JHSW-1000-BR-DRG-000111
- Rail: Attachment 2 –
 - Envelop of future rail corridor under SB41/42 - SGWS1-JHSW-2000-RW-DRG-101021

- Vertical clearance to the future rail over SB41/42 - SGWS1-JHSW-2000-BR-DRG-410110 and 410111
