

## Submission for Eastern Creek REP Throughput Increase

This submission is an objection to the Bingo REP Throughput Increase. The Negative impacts of this development are unacceptable.

The Bingo landfill has been exposing families to horrendous odours for years and there is no way they should be allowed to expand the limit to receive an additional 950,000 tonnes.

In 2021 our group discovered via GIPA that Bingo accepted and landfilled toxic medical incinerator ash in 2018 from the Cleanaway Medical Incinerator at Silverwater. Please find this information attached. This was in breach of their EPA licence. The fact Bingo is using a flare to burn off gas in the landfill is cause for concern. This could <u>spread dioxins</u> <u>everywhere</u>. This was kept a secret from the community and we still don't know if the toxic ash is sitting in the landfill like an environmental ticking time bomb. The WHO states "Dioxins are highly toxic and can cause reproductive and developmental problems, damage the immune system, interfere with hormones and also cause cancer". This proves Bingo has no concern for the community at all; there is no way they should be allowed to extend.

The EIS does not give a true indication of the overpowering stench suffered by the community over the past years. It falsely states the flare was effective in controlling odour issues in 2021. There have been hundreds of complaints from the community and the smell continues to be a major problem. There is no way this would be acceptable anywhere else in Sydney.

The community consultation on this project is non-existent. Families surrounding Bingo landfill have been treated terribly by Bingo. Bingo initially denied the smell complaints even though there were hundreds. Our community does not trust Bingo to do the right thing, as confirmed by their past behaviour.

Bingo is being prosecuted by the EPA for unlawful release of odours, so why is this application even being considered? This company has a history of operating outside the law and can't be trusted to do the right thing by the surrounding community. How can the Department Of Planning, in their right mind even consider this application?

Please consider the community living around the Bingo landfill site and do not approve this application.
