EIS SSD-53338465 Grand Avenue Data Centre Expansion, Rosehill

I refer to the Department's email of 25 October 2023 from NSW Department of Planning and Environment regarding the Environmental Impact Statement (EIS) for State Significant Development SSD-53338465 the Grand Avenue Data Centre Expansion, Rosehill for 'Construction and operation of an expansion to an existing data centre, with an overall height of 25.8 metres' at 8 Grand Avenue, Rosehill NSW 2142 (Lot 10 DP 1275083) in the City of Parramatta Council Local Government Area (LGA). Submissions need to be made to the Department by 23 November 2023.

The modification includes enlargement of the approved switching station by 4 metres towards Grand Avenue to accommodate Endeavour Energy's spatial requirements and modification to the wording of Condition 1 of the consent to enable the above changes to the design'.
