Has DPE engaged expert peer review of this Mod 15 application as suggested?

If so please provide a copy of any such review.

Time for submission should run from date of receipt of DPE's expert peer reviews. Otherwise there would be a patent denial of consultation as required by the Act as well as a denial of natural justice to members of the affected community.

What works within Mod 15 are precursors of Cadia's CCOP proposals, of which DPE has full knowledge, which have not as yet been assessed and which if not ultimately approved will have an unnecessary deleterious affect on the environment, as defined ?

What works has the mine undertaken , in the context of Mod 15 or otherwise for which there are no approvals ?

If there are , as we suspect , the Mine should embargoed/deferred from any further works until such time as the mine is in an approval timeframe as may have been approved in the normal course. Minor fines do not affect this Mine BUT deferment of approvals to counter jumped timeframes for any such works will make the mine comply with the rules of development approvals and be a precedent for other proponents not to jump the gun.

Attached is a document prepared by CCSN which identifies 18 matters of community concern regarding the Mod 15 Application.

I support and adopt these 18 points as part of my submission and seek leave to make further comment in respect thereof as has been agreed by DPE through to end January 2024 and longer depending upon your advices to the above matters.
