We spoke at the Community Drop In for the hospital. We live directly next door to the hospital on Merewether Street.

Firstly I wanted to thank you for facilitating the consultation with the community. As you can appreciate, feeling like you don't have access to information can be worrying with these type of developments.

I appreciate your offer to share the details of the plans with us, particularly in relation to the building that will be on our back fence. If you can send this by email, we would be grateful. This will allow us to reflect and send through any questions we have.

At this early stage, our two primary concerns are privacy and sunlight.

For your info, attached is an image of our courtyard that I took early afternoon on the weekend. The shadow from the existing single-level building (the current location of the Genea clinic) already reaches right across the ground so there is no sunlight at all on the ground during the day in winter. We are very concerned about a double or triple-story building there, I don't think we'd see much of the sun for months of the year. As discussed, our house is positioned to capture the north sun from that side.

We are keen to continue dialogue with your team about this to find the best outcome for everyone.
