The Dartbrook Coal Mine Modification 8 Proposal

We support the Hunter Thoroughbred Breeders' Association submissions in opposition to this modification 8 and highlight the following concerns with this proposal:

- Unacceptable air quality impacts, exceedances and greenhouse gas emissions exacerbating already unacceptably dusty and polluted conditions in the Upper Hunter;
- Unacceptable resulting health impacts for humans and horses;
- Unacceptable risks to our surface and groundwater systems; •
- Deleterious impacts on investment and economic diversity in the region; .
- Unassessed impacts on the Hunter's Equine Critical Industry Cluster; ٠
- Lack of genuine community consultation by the Proponent; ٠
- The absence of credible cumulative impact assessments importantly for air quality and water sources in the Hunter – against which proposals like this one can be benchmarked and assessed;
- Incompatibility of mining with international scale stud operations which are incompatible land uses.

In addition this proposal is at odds with:

- key Government policies aimed at protecting the Hunter's equine industry cluster; •
- protecting the environment; .
- protecting our cultural and Aboriginal heritage;
- fostering growth and diversity as we transition away from coal and towards more sustainable, zero emissions future:
- achieving the State's legislated targets for net zero emissions in 2030, 2035 and 2050; and
- the principles of ecologically sustainable development and inter-generational equity.

For the above reasons, we recommend the Department refuses this modification proposal.
