Re: Support for Proposed Modification - Bloomfield Colliery Life Extension

On behalf of Palaris, I write in support of the proposed modification to extend the life of the Bloomfield Colliery to the 31st of December 2035. This extension delivers clear economic, social, and community benefits that warrant approval.

The ongoing operation of the colliery will directly sustain hundreds of local jobs and provide stable employment for families across the region. It also underpins indirect employment across a network of contractors, consultants, and supply-chain businesses - many of them small and medium-sized enterprises embedded in the local economy. In regional NSW, where employment options can be limited, continued mining operations offer vital economic stability.

Beyond employment, The Bloomfield Group Foundation has invested in community programs across the Hunter Valley since 2006, with a strong focus on supporting vulnerable groups and health initiatives. Continued operations will enable the company to maintain - and potentially expand - its contributions to local education, sport, health, and welfare initiatives.

Crucially, this project allows workers to remain based in the Singleton area, avoiding the social impacts of fly-in fly-out (FIFO) arrangements and helping to keep families and communities connected.

Mining holds enduring value at both a community and national level. As Australia progresses toward decarbonisation, it is imperative to recognise that mining underpins this transition providing essential minerals for renewable technologies - and should be viewed as an integral component of a sustainable future.
