RE: SITE VERIFICATION CERTIFICATE APPLICATION

Wilpinjong Coal Pty Ltd (WCPL) owns the Wilpinjong Coal Mine, an existing open cut coal mining operation located approximately 40 kilometres northeast of Mudgee, within the Mid-Western Regional Local Government Area in central New South Wales (Figure 1). The Wilpinjong Coal Mine is located in the Upper Hunter Strategic Regional Land Use Plan area. Based on the NSW Government regional mapping (2013), no regionally mapped Biophysical Strategic Agricultural Land (BSAL) or Critical Industry Clusters are located within the vicinity of the mine (Figure 1).

WCPL is seeking a Site Verification Certificate (SVC) for potential future mining areas within Exploration Licences (EL) 6169 and 7091 (the SVC Application Area) (Figure 2) in accordance with Division 3 of the *Environmental Planning Policy (Mining, Petroleum Production and Extractive Industries) 2007*.

McKenzie Soil Management was commissioned by WCPL to conduct an Agricultural Resource Assessment of potential future mining areas surrounding the currently approved extent of Wilpinjong Coal Mine operations within Mining Lease (ML) 1573, EL 7091 and EL 6169. The Agricultural Resource Assessment included survey of 57 soil pit profiles dug with an excavator (detailed sites) and four spade/auger sites (check sites). 32 of these sites are located within the SVC Application Area (Figure 2).

McKenzie Soil Management has assessed the land within the SVC Application Area in accordance with the *Interim Protocol for Site Verification and Mapping of Biophysical Strategic Agricultural Land* (NSW Government, 2013). The attached McKenzie Soil Management Site Verification Report describes the assessment (Attachment 1). McKenzie Soil Management has verified that no BSAL is located within the SVC Application Area, which is consistent with the NSW Government's regional BSAL mapping.

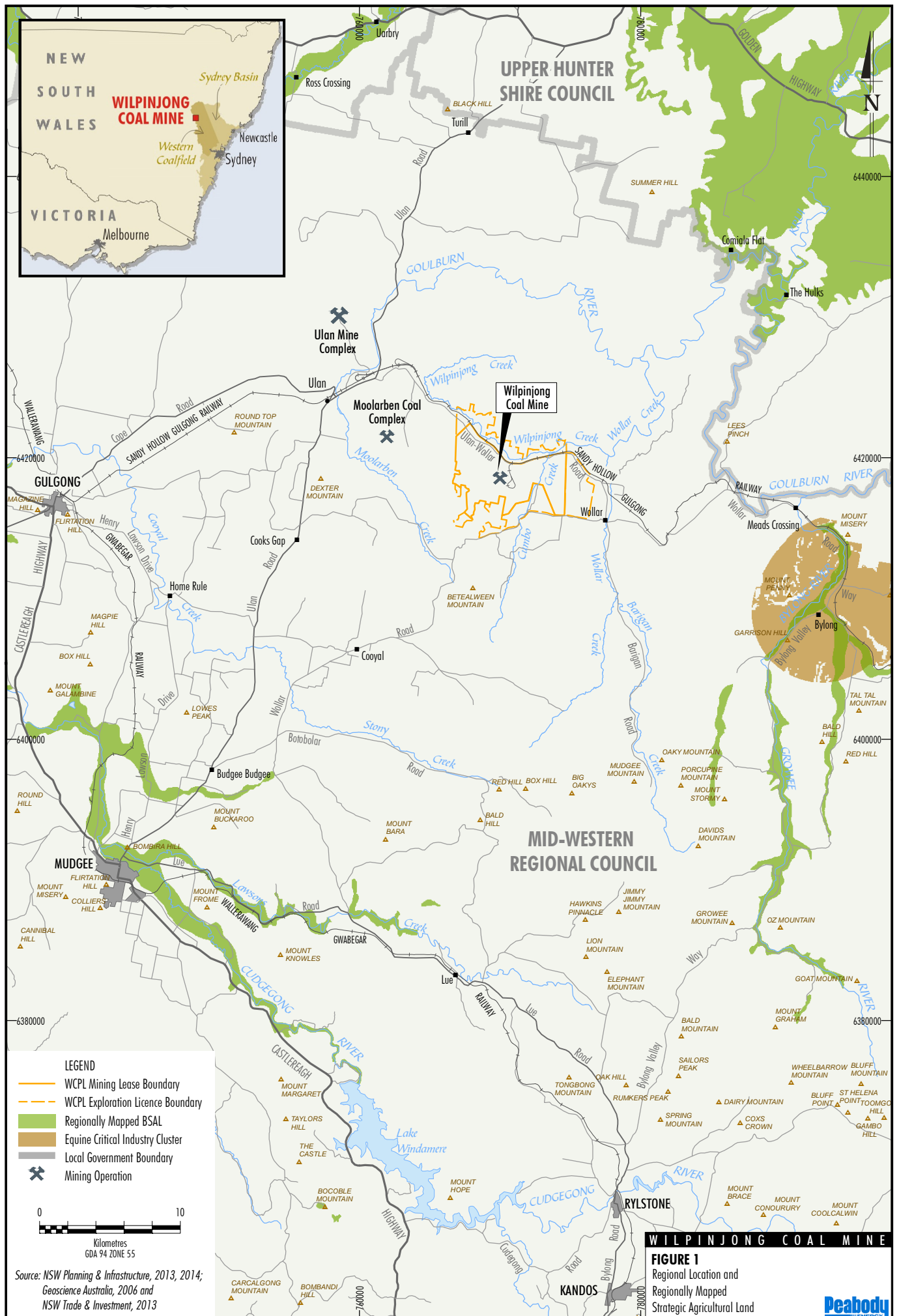

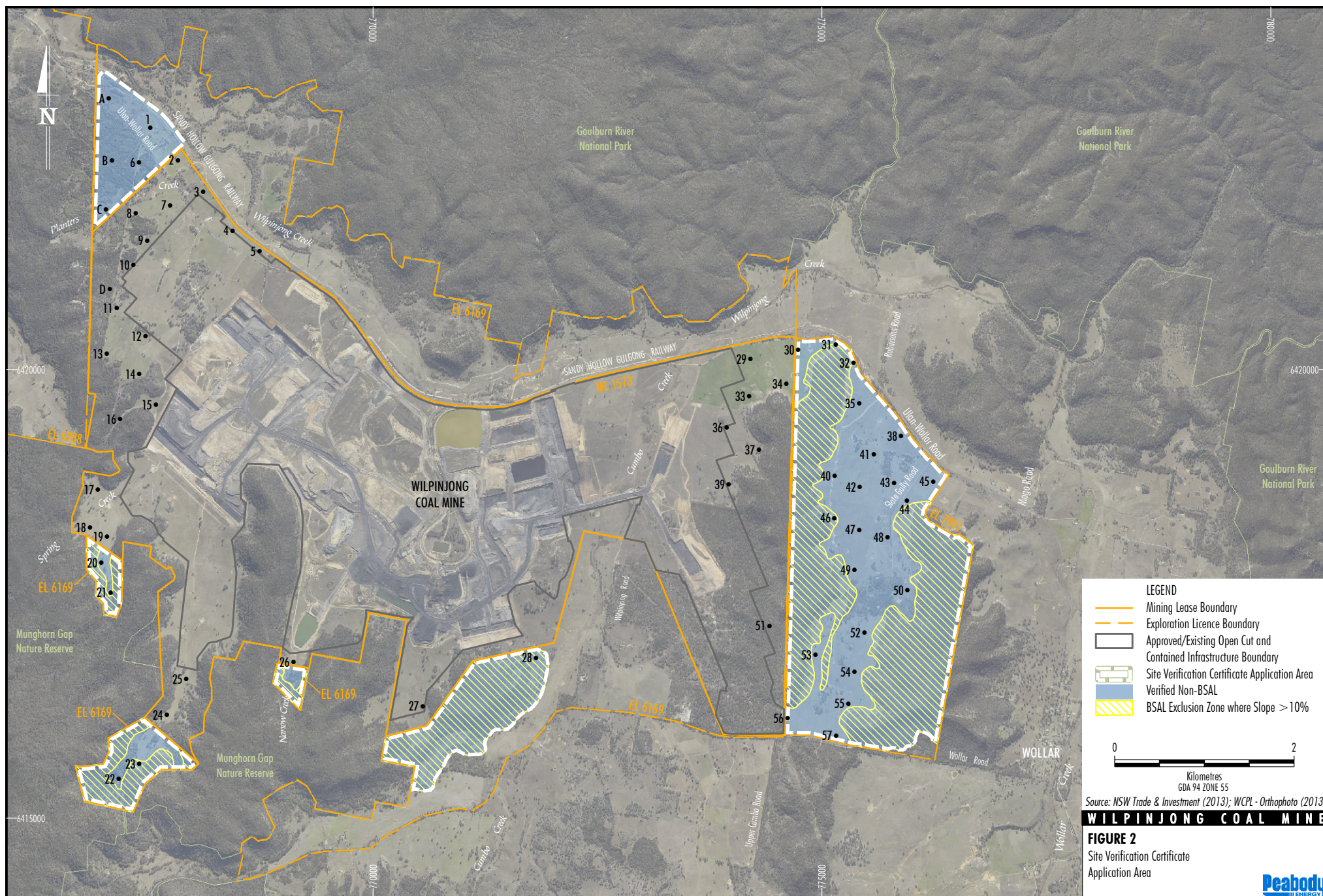
