1. Delete the definitions for "DEC" and "DNR" in the Definitions in Schedule 2, and insert in alphabetical order the following:

Statement of Environmental Effects

- 2. Delete all references to "DEC", "DEC (EPA)" and "DEC (NPWS)" and replace with "DECC".
- 3. Delete all references to "DNR" and replace with "DWE".
- 4. Delete condition 2(c) of schedule 2 and replace with:
  - c) Modification Application DA-128-5-2005 MOD 1 and the accompanying SEE titled "Proposed Minor Modifications to Lynwood Quarry, Marulan" dated January 2009; and
  - d) conditions of this consent.
- 5. Delete condition 3 of schedule 2 and replace with:
  - 3. If there is any inconsistency between the above documents, the most recent document shall prevail to the extent of the inconsistency. However, the conditions of this approval shall prevail to the extent of any inconsistency.
- 6. After condition 4 of schedule 2 insert the following:
  - 4A. The Applicant shall prepare revisions of any strategies, plans or programs required under this consent if directed to do so by the Director-General. Such revisions shall be prepared to the satisfaction of, and within a timeframe approved by, the Director-General.

- 7. In condition 13(b) of schedule 3 delete the words "Clean Air (Plant and Equipment) Regulation 1997" and replace with "Protection of the Environment Operations (Clean Air) Regulation 2002."
- 8. In the note preceding condition 16 of schedule 3 delete the words "Rivers and Foreshores Act 1948" and replace with "Water Management Act 2000"
- 9. In condition 41(a) of schedule 3:
  - (a) after the words "archaeological remains within", insert the words "the former"; and
  - (b) after the words "cistern/well (MRNH8)" insert the words "except where undertaken in accordance with the written approval of the NSW Heritage Council."
- 10. Delete condition 8 of schedule 5 and replace with:
  - 8. Within 6 weeks of completing each Independent Environmental Audit, the Applicant shall submit a copy of the audit report to the Director-General, together with its response to any recommendations contained in the audit report.
  - 8A. Within 3 months of submitting a copy of the audit report to the Director-General, the Applicant shall review and if necessary revise the strategies/plans/programs required under this consent, to the satisfaction of the Director-General.


