Modification Description

Dixon Sand is proposing an increase in extraction and production rate (from 250,000 to 495,000 tpa), an increase in the amount of Virgin Excavated Natural Material and Excavated Natural Material to be imported to the Quarry (from 100,000 to 250,000 tpa), a small extension in extraction area (1 hectare) and an increase in the number of trucks permitted to travel and from the Quarry (from 56 to 180 per day).

How is the modification substantially the same as the original development?

The site would continue to be operated as an extractive industry without modification to the method of extraction, processing, clean fill importation, landform construction and rehabilitation. The Proposed Modification would increase the rate of extraction, production and transport, however, these increases are to be balanced by the implementation of operational and environmental controls to ensure that these do not to impact on "material and essential" elements of the current development.
