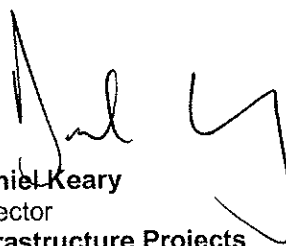


Modification of Minister's Approval

SCHEDULE 1

Development consent (DA-250-10-2004-i): granted by the Minister for Planning on 4 October 2005, and modified on 12 May 2010 and 13 July 2010.

For the following:

The construction and operation of a wind farm and associated infrastructure known as Woodlawn Wind Farm Project.

Modification Application (MOD 3):

Modification of the development consent to:

- increase the number of turbines from 20 to 23 Suzlon S88 2.1 megawatt (MW) turbines at the southern group of turbines, on Lot 55 DP 754919; and
- include additional associated ancillary infrastructure (kiosk transformers and hardstands and underground electrical and communications cabling) and access roads.

SCHEDULE 2

CONDITIONS

1. Inserting the additional words immediately after the last word of existing definition for *DEC* as follows:

, now incorporated within DECCW.

2. Inserting a new definition in Schedule 2, immediately after existing definition for *DEC* as follows:

DECCW	Department of Environment, Climate Change and Water.

3. Inserting a new definition in Schedule 2, immediately after existing definition for *ER* as follows:

Key Aboriginal Stakeholders	Aboriginal heritage stakeholders relevant to MP 10_0151_MOD3, including Pejar Local Aboriginal Land Council, Buru Ngunawal Aboriginal Corporation and DECCW.

4. Inserting a new definition in Schedule 2, immediately after existing definition for *SEE* as follows:

SEE (August 2010)	Supplementary Statement of Environmental Effects – Woodlawn Wind Farm Modification 3, prepared by Aurecon Australia for Woodlawn Wind Pty Ltd and dated 6 August 2010.

5. Replacing existing condition 2(j) with new conditions 2 (j), 2 (k) and 2(l) as follows:

- (j) Application to Modify a Development Consent, DA-250-10-2005 MOD2;
- (k) Application to Modify a Development Consent, MP 10_0151 MOD3, accompanied by *Supplementary Statement of Environmental Effects – Woodlawn Wind Farm Modification*, prepared by Aurecon Australia for Woodlawn Wind Pty Ltd and dated 6 August 2010; and
- (l) the conditions of this consent.

6. Inserting a new condition 25A immediately after existing condition 25 as follows:

Rock Outcrop Habitat

25A	The Proponent shall, where practicable, avoid disturbance to areas of rock outcrops, during construction of turbines 21, 22 and 23 and associated infrastructure, which is defined in the SEE (August 2010).

7. Inserting a new condition 29(d)(vii) immediately after existing condition 29(d)(vi) as follows:

29(d)(vii)	section 7.6 of the main report of the SEE (August 2010).

8. Inserting a new condition 57A immediately after existing condition 57 as follows:

- 57A The mitigation measures identified in the SEE (August 2010) in section 10.4.3 of the main report and section 8.1 of Appendix G, shall be incorporated in the CEMP, within the Cultural Heritage Management Sub Plan. The CEMP shall include evidence of the consultation undertaken to date with Key Aboriginal Stakeholders, clearly indicate the issues raised by stakeholders during consultation, and how those matters have been addressed.

9. Inserting a new condition 57B immediately after new condition 57A as follows:

- 57B Woodlawn Wind Pty Ltd shall submit to DECCW, AHIMS Site Recording Forms for the three identified Aboriginal heritage finds (WLWF1, WLWF2 and WLWF3), to the satisfaction of DECCW and prior to the commencement of works identified in the SEE (August 2010).

10. Replacing existing condition 62 with new condition 62 as follows:

- 62 Details of the construction timetable are to be submitted to CASA and AirServices Australia prior to the commencement of Construction.

11. Replacing existing condition 63 with new condition 63 as follows:

- 63 The following details are to be submitted to CASA and AirServices Australia prior to the commencement of Operation:
- (a) the 'as constructed' coordinates of the wind turbines (in latitude and longitude);
 - (b) the final height in metres AHD for each wind turbine; and
 - (c) the ground level at the base of each of the wind turbines, in metres AHD.

12. Replacing existing condition 69 (d) with new conditions 69(d) and 69(e) as follows:

- 69(d) providing a land line between the affected receiver and an antenna located in an area of favourable reception; and
- 69 (e) implementing the mitigation measures listed in the SEE (August 2010) in section 9.3.2 of the main report.
