- 2. Replace all references to "Director-General" with "Planning Secretary"; "DECCW" with "EPA" and "shall" with "must".
- 3. Delete Conditions 1.2 and 1.2A, accompanying table and subheading "Scope of Development" and replace with new subheadings and new Conditions 1.2 to 1.2B:

#### **Terms of Consent**

- 1.2 The development may only be carried out:
  - a) in compliance with the conditions of this consent;
  - b) in accordance with all written directions of the Planning Secretary;
  - c) in accordance with the EIS documents and additional information outlined in Appendix No. 2;
  - d) in accordance with the Development Layout in Appendix No. 3;
  - e) in accordance with MOD 1; and
  - f) in accordance with MOD 2.
- 1.2A Consistent with the requirements in this consent, the Planning Secretary may make written directions to the Applicant in relation to:
  - the content of any strategy, study, system, plan, program, review, audit, notification, report or correspondence submitted under or otherwise made in relation to this consent, including those that are required to be, and have been, approved by the Planning Secretary; and
  - b) the implementation of any actions or measures contained in any such document referred to in condition 1.2Aa).
- 1.2B The conditions of this consent and directions of the Planning Secretary prevail to the extent of any inconsistency, ambiguity or conflict between them and a document listed in condition 1.2c), e) or f). In the event of an inconsistency, ambiguity or conflict between any of the documents listed in conditions 1.2c), e) or f), the most recent document prevails to the extent of the inconsistency, ambiguity or conflict.
- 4. Delete Condition 3.29 and replace with the following:
  - 3.29 The Applicant must ensure that wastewater is only applied to the 'effluent utilisation areas' as identified in Drawing No. A8-114-20-08, Revision B, *Proposed Additional Effluent Irrigation Area*, dated 10 June 2019, included in Appendix No. 3.
- 5. Insert new Condition 3.29A after Condition 3.29 as follows:
  - 3.29A Notwithstanding condition 3.29, the Applicant shall not apply wastewater (effluent) to new effluent utilisation areas approved under MOD 2 within:
    - a) 100 metres of the Severn and Beardy Rivers; or


- b) 25 metres of any internal drainage lines serviced by terminal ponds; or
- c) 50 metres of any internal drainage lines that do not have terminal ponds; or
- d) 50 metres of public roads; or
- e) 50 metres of any public spaces.
- 6. Insert new Condition 3.30A after Condition 3.30 as follows:
  - 3.30A The Applicant must only apply effluent to irrigation areas via spray, pivot or drip irrigation methods.
- 7. Delete Condition 3.31 and replace with the following:
  - 3.31 The Applicant must ensure that solid wastes (manure) are only be applied to the 'manure utilisation areas' as identified in Drawing No. A8-114-20-09, Revision B, *Proposed Additional Manure Application Area*, dated 10 June 2019, included in Appendix No. 3.
- 8. Delete Condition 3.33c) and insert new Conditions 3.33c) and 3.33d) as follows:
  - 3.33 Notwithstanding condition 3.31, the Applicant must not apply solid wastes (manure):
    - a) on any site that may lead to the contamination of groundwater, or
    - b) within 100 metres of any watercourse; or
    - c) within 50 metres of any public road; or
    - d) within 50 metres of any public spaces.
- 9. In Conditions 3.37 and 3.38, replace "7:00am" with "5:00am",
- 10. Insert new Condition 3.49A, 3.49B and 3.49C after Condition 3.49 as follows:
  - 3.49A Prior to undertaking any clearing of 'Blakely's Red Gum Yellow Box grassy woodland (PCT 510)', or activities that have the potential to impact upon this plant community type, the Applicant must purchase and retire eight (8) ecosystem credits and nineteen (19) species credits to offset the removal/disturbance of 0.59 hectares of native vegetation including the removal of seven paddock trees at the site. The ecosystem credits must be retired in accordance with the requirements of the EES Group's Biodiversity Offsets Scheme and the *Biodiversity Conservation Act 2016*.
  - 3.49B The requirement to retire like-for-like ecosystem credits (see Condition A1) may be satisfied by payment to the Biodiversity Conservation Fund of an amount equivalent to the number and classes of ecosystem credits, as calculated by the EES Group's Biodiversity Offsets Payment Calculator.
  - 3.49C The Applicant must provide the Planning Secretary with evidence that:
    - c) the retirement of ecosystem credits has been completed (see Condition A1); or
    - d) a payment has been made to the Biodiversity Conservation Fund (see Condition A2), prior to undertaking any clearing of PCT 510, or activities that have the potential to impact upon this plant community type.
- 11. Delete Condition 6.3h) and insert new Condition 6.3h) as follows:
  - 6.3 The Applicant shall prepare and implement an **Operational Environmental Management Plan** (OEMP) to detail an environmental management framework, practices and procedures to be followed during operation of the development. The plan shall include, but not necessarily be limited to:
    - the environmental monitoring requirements outlined under conditions 4.1 to 4.8 of this consent, inclusive; and
- 12. Insert new subheading and Conditions 6.7, 6.8 and 6.9 after Condition 6.6 as follows:

### Revision of Strategies, Plans and Programs

- 6.7 Within three months of:
  - a) the submission of a Annual Environmental Management Report under condition 7.3;
  - b) the submission of an incident report under condition 7.1;
  - c) the submission of an Environmental Audit under condition 4.11;
  - d) the approval of any modification of the conditions of this consent; or
  - e) the issue of a direction of the Planning Secretary under condition 1.2(b) which requires a review,
- 6.8 the strategies, plans and programs required under this consent must be reviewed.
- 6.9 If necessary to either improve the environmental performance of the development, cater for a modification or comply with a direction, the strategies, plans and programs required under this consent must be revised, to the satisfaction of the Planning Secretary. Where revisions are required, the revised document must be submitted to the Planning Secretary for approval within six weeks of the review.

**Note:** This is to ensure strategies, plans and programs are updated on a regular basis and to incorporate any recommended measures to improve the environmental performance of the development.:
