OEH has reviewed the updated <u>Aboriginal Cultural heritage Assessment Ramp 22 Sedimentation Dam - Bulga Coal surface Operations & Mount Thorley Operations, prepared by RPS Australia East Pty Ltd, for Coal and <u>Allied - Mount Thorley Warkworth, November 2013</u> in regards to OEH's initial assessment and comments on <u>DA - 41-03-99 MOD 8</u>, dated 22 August 2013.</u>

OEH is now satisfied that the three outstanding issues identified in the EA with regards to:

- Inadequate Aboriginal cultural heritage assessment process;
