 - (d) include details of any outstanding issues raised by the stakeholder and an explanation of disagreement between any stakeholder and the Applicant.

COMPLIANCE

- 15. The Applicant must ensure that all employees, contractors and sub-contractors are aware of, and comply with, the conditions of this consent relevant to their respective activities.
- 4. In condition 16B of Schedule 4, after the words "privately-owned land" insert the words "within 3 kilometres of any approved open cut mining pit on the site, or any other privately-owned land where the Secretary is satisfied that an investigation is warranted, ".
- 5. After condition 2 of Schedule 6, insert the following:

Relationships Between Strategies, Plans or Programmes

- 2A. With the agreement of the Secretary, the Applicant may combine any strategy, plan, program or Annual Review required by this consent with any similar strategy, plan, program or Annual Review required for HVO South and Mt Thorley Warkworth mines or any other adjoining operation in common ownership or management.
