Briefly describe what the original approval allows

The Minister for Urban Affairs and Planning granted Development Consent (DA 73-11-98) on 14 May 1999. The Development Consent authorised the extension of mining operations in an area of approximately 15 km² which was between the historic Newstan Colliery and the historic Awaba Colliery. The Development Consent also authorised the upgrade of the Colliery's surface facilities. The Development Consent has subsequently been modified on seven occasions.

5. Describe the modification you propose to make to the approval

Describe the proposed modification

Proposed Modification 8 involves:

- (a) the establishment of first workings in an area partly within and partly adjoining the area authorised to be mined by the Development Consent. The first workings are in an area which is already the subject of our mining leases, namely ML 1452 and CCL 746. It is proposed to extract a total of 2Mt of ROM coal from the first workings; and
- (b) the modification of condition 1.2 of the Development Consent which currently limits the period in which mining can occur, to 6 July 2020. It is proposed that the period be extended by 12 months to 6 July 2021.

Your modification request may need to be accompanied by an Environmental Assessment, including plans. An electronic and hard copy of this document will be required.


