I refer to your request for an Airservices assessment of the Wyong Hospital Expansion development and crane operation at 664 Pacific Hwy, Hamlyn Terrace.

Airspace Procedures

With respect to procedures designed by Airservices in accordance with ICAO PANS-OPS and Document 9905, at the maximum heights of 45.95m (151ft) AHD and 127m (417ft) AHD, the development and the crane operations, respectively, will not affect any sector or circling altitude, nor any instrument approach or departure procedure at Gosford District Hospital.

The development and the crane operations will not affect the Sydney Radar Terrain Clearance Chart (RTCC).

Note that procedures not designed by Airservices at Gosford District Hospital or Lake Macquarie Airport were not considered in this assessment.

Communications/Navigation/Surveillance (CNS) Facilities

The development and crane operation will not adversely impact the performance of Precision/Non-Precision Navigational Aids, HF/VHF Communications, A-SMGCS, Radar, PRM, ADS-B, WAM or Satellite/Links.
