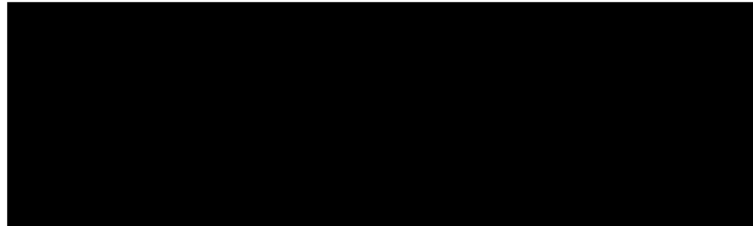

and on Saturday. Then continuous noise in operation .Our peace will be gone.

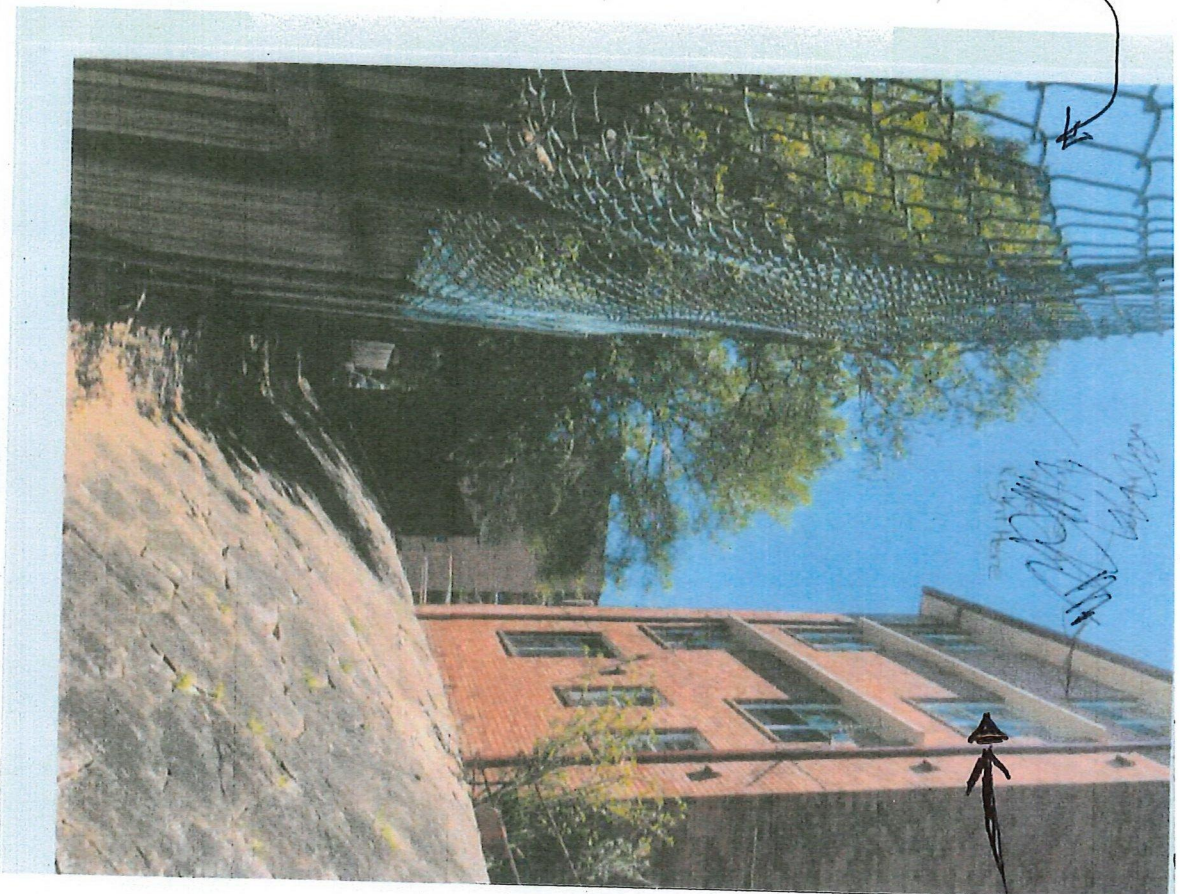
