UPC Renewables has submitted a Development Application (DA) for the New England Solar Farm, located approximately 6km east of the township of Uralla, within the Uralla Shire local government area.

The proposal involves the construction, operation and decommissioning of a 720 megawatt photovoltaic solar farm and development of associated infrastructure, including an energy storage facility and grid connection.

The DA and Environmental Impact Statement (EIS) will be on public exhibition from **Wednesday 20 February 2019** until **Wednesday 20 March 2019**.
