

The residents live in threat of danger while there is only one exit on the estate. Besides, land values will increase when there are two exits.



The Project Approval (MP 06_0250) was approved on 28 June 2010 by the then Deputy Director-General, Development Assessments and Systems Performance, as delegate of the then Minister for Planning, for a 411 lot residential subdivision to be constructed over 17 stages. The Project Approval also included associated earthworks, open space, construction of the road network, asset protection zones, landscaping and construction of associated infrastructure.
