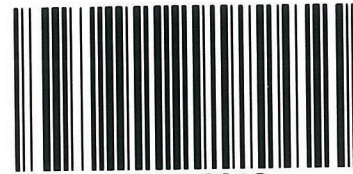


**I, feel sadden by the fact that children are put at risk for no good reason except for the greed of some developers.**
