Timor

Reason for Objection – Groundwater Pumping.

Section 3.2.1 states that the project may be pumping up to 1.2 million litres per month from groundwater.

We are situated in Timor and during the recent five-year drought two of our three groundwater springs ceased flowing and the third one was dangerously low when relief rain came in December 2019.

If the Wind Farm project was to draw ground water upstream from our property, I fear it will significantly affect our property.

We draw water from this spring as our normal farm practice and do not have the infrastructure to draw water from nearby rivers if they are flowing.

Many other properties in this vicinity also rely on their ground water springs.

There is no mention in the EIS of any ground water studies being carried out.

This project should not proceed without suitable independent studies of ground water in the area.
