As former and longest serving President of the Nundle Business, Tourism and Marketing Group Inc. (NBTMG Inc. or the Group) and founding member, the current leadership has used the Group as a forum to oppose the Hills of Gold Windfarm proposal and they base their position on a meeting attended by members in 2018. A vote, taken at this meeting, showed a majority opposed the Project with a few undecided and one for the project. Members present at this meeting were not a representative sample of the entire membership. The Group took a view that they would oppose the Hills of Gold Wind Farm SSD No. 9679 (The Project) and, despite more information being made available, there has never been a full member poll on whether members are for or against. Since this stance was taken, several members have withdrawn membership or reduced funding of the group and several prospective new business entrants into Nundle or Hanging Rock have decided not to join the Group.

I have prepared a document showing business entities listed on the <u>www.nundle.com.au</u> website and some businesses not listed on the website. I have excluded agricultural holdings / business entities. I have tabulated the views of these entities. Please see Table 1.

It is clearly evident that the majority of businesses in Nundle and Hanging Rock support The Project by 23 IN SUPPORT vs 9 AGAINST.

I would like to add that business owners have told me that they are afraid to overtly show support of The Project because they do not want to be bullied or boycotted if they do so by the very active and vocal opponents to The Project.

Many businesses in the Nundle / Hanging Rock area are struggling to make ends meet and some, including new start-ups, have closed. Membership of the Group has stalled or is diminishing due to the Group's political nature or stance. The Hills of Gold Wind Farm presents an opportunity for existing businesses to prosper and for new businesses to be established.



I am of the view that world class tourism opportunities will emerge from the wind farm project, one such being a professionally designed <u>mountain bike course</u>. The area is spectacular and the views from the ridge-line are breathtaking.
