

Other Business (Stormwater):

- 1. On Site Detention is not required if the subject development proposes direct stormwater connection to Sydney Water's stormwater system.
- 2. Proponent has confirmed in the meeting that there are no building or permanent structures proposed over the stormwater channel or within 1m from the stormwater channel or within Sydney Water land.
- Proponent is required to submit a Flood Impact Assessment (FIA) report based on a current flood model for the proposed development and identify flood hazards. The FIA must:
 - a. Demonstrate that there are no potential adverse flood impacts offsite due to the development; and
 - b. Evaluate the impacts of flooding on the proposed development.
- 4. Appropriate flood mitigation actions are to be implemented should there be any impact on existing flooding due to the proposed development.
- 5. Sydney Water has no objection to use of existing two bridges, provided these bridges are structurally adequate for the intended use. However, replacement of the existing bridges at the end of its lifespan is subject to Sydney Water's review based on its merit.
- 6. Sydney Water has no objection to the extension of the existing culvert on the upstream end, if any pipe works are proposed to cross over the Sydney Water's stormwater channel at the upstream boundary. However, the extension of the culvert is to be limited to the existing upstream bridge.
- 7. Finally, Sydney Water has no objection to extending the existing culvert on the downstream end to widen the existing road, provided the extension is limited to the required maximum width for vehicular crossing.

Other Business (Sewer):

1. Our servicing investigation show that the existing 200mm sewer pipe along King Street may accommodate 600EP depending on its physical condition. In addition, SWC recommends that once a Water Service Coordinator is engaged by Qantas, the sewer type, size, depth and condition is to be verified in the field inspection.



Other Business (Property):

- The License agreement between Sydney Water and Qantas expired in April 2015.
 Therefore, the tenancy is currently on holdover. SWC intends to renew the agreement for another 10 years.
- 2. Qantas to provide SWC (c/o Sue DeSilva) the exact details on parcel of land with possible "railway ownership" for clarification.
