1. Noise

The Department requests further information on the predicted frequency of operation of the coal handling equipment at Mannering to accommodate the increase in run-of-mine coal production. Will this increase operating hours during the evening and night period? Are there any options to limit the operating hours of Mannering's coal handling plant, particularly during the night period?

2. Air Quality

Lake Macquarie City Council's submission for Mannering Colliery Mod 5 seeks clarification on the predicted increases in the 24-hour average PM_{10} concentrations, as represented in Table 8-5 of the Statement of Environmental Effects. Please provide clarification regarding any predicted air quality exceedances.

3. Coastal Management

Delta Coal must consider any relevant requirements of *State Environmental Planning Policy (SEPP) (Coastal Management) 2018* and include a detailed consideration of clause 15 of that SEPP. Please refer to the Biodiversity and Conservation Division's (BCD, formerly the Office of Environment and Heritage) submission.

4. Heritage

The BCD submission recommends that revised Aboriginal Cultural Heritage Management Plans be prepared for Chain Valley and Mannering Collieries.

The Department supports the BCD's recommendations and suggests that it would be efficient for Delta Coal to prepare an updated Aboriginal Cultural Heritage Management Plan
