Dear Jane

I, like other Cadia Residents would like to thank you for meeting with residents (I was in Sydney unable to attend) on Thursday and playing your part in the DPIE extending the Mod 14 Exhibition (submissions) period to 19/2/21.

What I find disturbing on the part of Newcrest/Cadia , CVO , is the fact that 1, a known interested community participating Cadia Resident , was never notified of this Exhibition Period by CVO !

This is despite me having received no less than eight emails from Matthew Armstrong regarding matters relevant to Mod 14 submissions after the commencement of the Exhibition Period – 18/1/20, 21/12/20, 27/2/21, 27/2/21, 28/2/21, 28/2/21, 2/2/21 & 2/2/21 and six emails from Lindsey Tilberg, more community related, since her 18/12/20 email and CVO posted material **YET the opening of the Exhibition Period was never mentioned** until Matthew's following email advising extension of the Exhibition.

What is as galling to me is that recent Consent Modifications have been approved during periods, for example the second half of 2019, when I was in full blown communications, meetings, emails and even agreements with Peter Sharpe, then General Manager of CVO and Matthew Armstrong **YET NO NOTICES** of Exhibition of these modification applications were ever received. I like others would have made strident objections to matters approved in those Applications.

CVO's attitude towards Cadia Residents and the wider community can only , at best , be perceived as disingenuous.

I trust CVO takes these comments on board and agrees that Cadia Residents and other relevant wider community members are given direct notice of all future Modification or other State or Local Government Applications .
