Good morning

Hera Resources Pty Limited has submitted a modification application for the Hera Gold Mine Project (10_0191 MOD 4), located within Cobar local government area.

The proposal includes:

- A minor extension to the existing underground mine and northern project boundary to access an additional 62,000 tonnes of gold-zinc-lead ore; and
- Establishing a new northern fresh air intake rise and access decline in support of the proposed extension.

There would be no change to the rate of processing, life of mine, waste disposal, existing surface infrastructure or product transport.

The modification application and Environmental Assessment (EA) will be on public exhibition from **Wednesday 27 April 2016** until **Wednesday 11 May 2016**.

I have arranged for the proponent to deliver a hard copy of the EA to you directly. This document may also be viewed on the Department's website at the commencement of the exhibition period (<http://majorprojects.planning.nsw.gov.au/page/on-exhibition/>).
