I refer to the above application and your email dated 27 April 2018 seeking Council's comments and advice on the modifications and conditions of approval.

The proposed modification seeks to:

- Convert an 8.83m² area of unused plant storage to retail for use as a coffee shop (takeaway only);
- Reconfigure the openings at the north-eastern corner of the building, with minor alterations to the northern and eastern elevations to create the coffee shop serving area; and
- Amend consent Conditions A2, B5 and B6 to account for the resultant changes to:
 - the approved architectural drawings; and
 - monetary contributions.

You are advised that Council has no general objection to the proposed modifications.

Section 94 Contributions and Railway Infrastructure

The contribution will be:

36796 (previous increased GFA over existing building) + 264 (MOD 6 increase) + 8.83 (MOD 7 increase) x 127.51 = **\$4,726,646.51**
