# **Biodiversity**

1. An exemption to the Framework for Biodiversity Assessment (FBA) has been granted by OEH

The proponent requested an exemption from the FBA under the NSW Biodiversity Offsets Policy for Major Projects in correspondence dated 5 April 2018, on the basis the site was highly disturbed and devoid of any biodiversity values. OEH was satisfied with the request and agreed no further biodiversity assessment was required. Exemption from the FBA was provided to the proponent on 12 April 2018.

#### Recommendation 1

OEH has granted an exemption from the FBA for the project and no further biodiversity assessment is required.

# Aboriginal Cultural Heritage

2. The exemption does not extend to the Aboriginal cultural heritage

In the Environmental Impact Statement (EIS), the proponent requested an extension to the timeframes to allow for archaeological testing to determine the nature and scope of the Aboriginal cultural heritage potential of the site. OEH supported the proposed extension.

However, in the RTS document, the proponent has mistakenly applied the FBA exemption to the Aboriginal cultural heritage assessment. This is incorrect. The FBA exemption only applies to biodiversity.

#### Recommendation 2

OEH supports the extension of timeframes to allow the archaeological testing to determine the nature and scope of the Aboriginal cultural heritage potential of the site. OEH will review the ACHAR once submitted.
