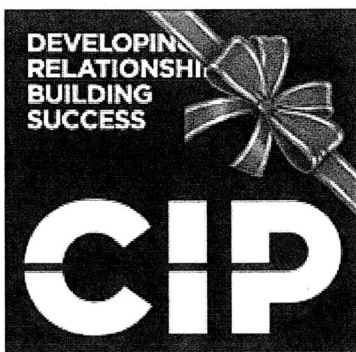

Hi Steven,

The Nulon Facility is proposed on Lot 8 which is the most eastern lot within the Bringelly Business Hub. Please find attached estate masterplan showing the location of the facility and a site plan showing more details of the facility.

I have attached the landscape drawings and the Visual Impact Assessment Report provided in the DA application which includes artist impressions to give you a better understanding of the completed facility and the interface between sensitive receivers. The landscape design is in accordance with the concept approval and site design guidelines of State Significant Development approval, the proposed Nulon Development incorporates a 5m landscaped buffer to the eastern boundary.

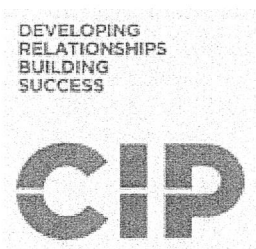
There are no retaining walls required along the eastern boundary, as we are incorporating landscaping within a batter zone allowing integration into the existing levels. I have attached the civil drawing showing the proposed levels. We would also like to discuss an option to incorporate a retaining wall which we can provide you further details in person.

The facility is only for storage and distribution, products which will be stored include aerosol cans, and other combustible liquids however, this has been assessed and the appropriate building solutions have been incorporated to ensure the facility is constructed to Australian Standards. A Dangerous Goods Report was also completed as part of the DA application to assess the products stored within the facility and concluded the facility is not classified as potentially hazardous.

We would like the opportunity to meet with you on site and go through the drawings and the proposed development. Please let me know when you are available to meet.

Hi Tim,

The proposal to build the Nulon Oil facility @ Bringelly Rd has upset me greatly.

I was never against the business park and what was proposed at the time, but this application has no place within the confines of the Parklands. Not wishing it in any bodies backyard, but this type of industry is more suited out near the new proposed airport away from residential development.

I asked one question around the use of the facility and the developers answer contradicted the plans provided. How do you think that makes me feel?

The facility is only for storage and distribution, products which will be stored include aerosol cans, and other combustible liquids however, this has been assessed and the appropriate building solutions have been incorporated to ensure the facility is constructed to Australian Standards. A Dangerous Goods Report was also completed as part of the DA application to assess the products stored within the facility and concluded the facility is not classified as potentially hazardous.

At no point was there any consultation between the developer and myself around what was being planned. The first notice I received was the email Christmas Eve (2ish in the afternoon), and how ironic the timing has proven to be.

Through all our meetings I have assessed you as a fair person. I understand some of these decision are post your involvement, and out of your control, but to me it was the original development application from your area that has now placed me in this position.

The thing that really stands out, is if CIC get the tick of approval for this facility, you can only dread to imagine what they have in the works for the remainder of the park.

This type of industry has no place in close proximity to residential development.

My strong objection to the proposal will be lodged.

are in appropriate terms and the orders made below embody the requirement for giving effect to these.

ORDERS

215 It follows that, as a consequence of all the foregoing, the orders of the Court are that:

- (1) The Defendant is convicted of the offence as charged;
- (2) Pursuant to s 250(1)(e) of the *Protection of the Environment Operations Act 1997*, the Defendant is to pay the amount of \$120,000 to the Environmental Trust established under the *Environmental Trust Act 1998* for general environmental purposes;
- (3) Pursuant to s 250(1)(b) of the *Protection of the Environment Operations Act 1997*, the Defendant is to take specified action to provide a written apology in the terms set out at Annexure A to those persons employed by Sphere Healthcare, as referred to in Exhibit A Tab F affected by the incident;
- (4) Pursuant to s 257B of the *Criminal Procedure Act 1986*, the Defendant is to pay the Prosecutor's legal costs of \$64,530;
- (5) Pursuant to s 248(1) of the *Protection of the Environment Operations Act 1997*, the Defendant is to pay the Environment Protection Authority's investigation costs of \$674.82; and
- (6) Pursuant to s 250(1)(a) of the *Protection of the Environment Operations Act 1997*, the Defendant will:
 - (a) Within 28 days of the date of this order, at its expense, cause a notice in the form of Annexure B at a minimum size of 10 cm x 18 cm to be placed in:
 - (i) The Liverpool Leader;
 - (ii) The Sydney Morning Herald; and
 - (iii) PACE Process Control & Engineering.
 - (b) Within 35 days of the date of this order, provide to the Prosecutor a complete copy of the page of the publications in which the notice appears.
